- Department records show that Surface Water Appropriation A-15917R is held by Royal River Farms LLC.
- 2. Appropriation A-15917R has a priority date of **July 7, 1981**, and authorizes use of water for irrigation on **64.0 acres**, described below. Water may be diverted from **the Elkhorn River** at a points of diversion located on the right bank of the stream in the **SE**½NE¾ of **Section 07**, **Township 23 North**, **Range 01 East of the 6<sup>th</sup> P.M. in Stanton County**. The maximum diversion rate shall not exceed **0.91 cubic feet** per second (cfs).

- 3. Based on information received and records reviewed, the Department has determined that Appropriation A-15917R has not been used for irrigation for more than five consecutive years, as required by Nebraska law.
- 4. At this time, the Department is unaware of any sufficient cause for nonuse under Neb. Rev. Stat. § 46-229.04.
- 5. Pursuant to **Neb. Rev. Stat. § 46-229.02,** this Notice serves as preliminary notification that Appropriation A-15917R will be **cancelled** unless this determination is successfully contested.
- 6. Landowners with a legal interest in the land under this appropriation may:
  - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-15917R.
