**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-3472**

WATER DIVISION 2-A

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-3472 is held by the Dana E. and Judy K. Christman Family Trust.
2. Appropriation A-3472 has a priority date of July 26, 1941, and authorizes the use of water for irrigation of the 131.24 acres of land described below. The water may be diverted from Looking Glass Creek at points of diversion located on both banks of the stream in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 05, Township 17 North, Range 03 West of the 6th P.M. in Platte County. The rate that water may be diverted shall not exceed 0.94 cubic feet per second (cfs) from all points of diversion.

3. The Department has received information concerning the use of surface water appropriation A-3472 and determined that the appropriation has not been used for irrigation purposes for more than five consecutive years as required under Nebraska law.
4. At this time, the Department knows of no reason that constitutes sufficient cause for nonuse under Neb. Rev. Stat. § 46-229.04.
5. In accordance with state law (*Nebraska Revised Statutes* § 46-229.02) this notice is to inform you that appropriation A-3472 will be cancelled unless the Department's determination is successfully contested.
6. The owner(s) of the land that may be irrigated under water appropriation A-3472 may:
 - A. Choose not to respond to this Notice. **If no timely response is received the Department will proceed to enter an order cancelling all of water appropriation A-3472.**

- B. Contest the Department's Preliminary Determination by filing the enclosed contest form in the Department at its Lincoln office: 245 Fallbrook Blvd, Suite 201, Lincoln, Nebraska 68521 by the close of business on March 14, 2025. No filing fee is required.
7. Enclosed are: (1) a copy of the laws governing cancellation of appropriations, Neb. Rev. Stat. §§ 46-229, 46-229.02, 46-229.03, 46-229.04 and 46-229.05; (2) a blank contest form; and (3) a copy of the Report of Field Investigation which is the basis for the determination.
