**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE  
OF SURFACE WATER APPROPRIATION A-8768**

WATER DIVISION 2-B

1. Department records show that Surface Water Appropriation A-8768 is held by **John and Mary Krysl**.
2. Appropriation A-8768 has a priority date of **August 23, 1956**, and authorizes use of water for irrigation on **88.0 acres**, described below. Water may be diverted from **the Elkhorn River** at a points of diversion located on both banks of the stream in the **NW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 22, Township 30 North, Range 15 West of the 6<sup>th</sup> P.M. in Holt County**. The maximum diversion rate shall not exceed **1.25 cubic feet** per second (cfs) from all points of diversion.

3. Based on information received and records reviewed, the Department has determined that Appropriation A-8768 has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.
4. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
5. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-8768 will be **cancelled** unless this determination is successfully contested.
6. Landowners with a legal interest in the land under this appropriation may:
  - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-8768.
  - B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) no later than **January 19, 2026**. **No filing fee is required**.
