**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-11090**

WATER DIVISION 2-B

1. Department records show that Surface Water Appropriation A-11090 is held by **David L. and Quana K. Laursen.**
2. A search of the Holt County Register of Deeds indicates the land appurtenant to Appropriation A-11090 has been divided into separate parcels. Additional individuals—other than those listed in Department records—may now be landowners. These include **Evelyn Laursen Trust; Central Valley Ag Co-operative; Cargill, Incorporated; HCT, LLC; John R. Prouty; J.E. Meuret Grain Co., Inc.; Randall J. and Brenda J. Hupp; Adam J. Crist; EHH Shamrock, LLC; Dowd Grain, LLC; Clarence C. and Ann L. Wrede; and Bobby B. and Colleen M. Eby; Laursen O'Neil Car Wash, LLC, and PHD MAXIMUM CROP, LLC.**
3. Appropriation A-11090 has a priority date of **April 3, 1967**, and authorizes use of water for irrigation on **204.4 acres**, described below. Water may be diverted from **the Elkhorn River** at points of diversion located on the left bank of the stream in the **NW¹₄NE¹₄, NE¹₄SE¹₄ and on the right bank in the SE¹₄SE¹₄ of Section 32, Township 29 North, Range 11 West of the 6th P.M. in Holt County.** The maximum diversion rate shall not exceed **2.92 cubic feet** per second (cfs) from all points of diversion.

4. Based on information received and records reviewed, the Department has determined that Appropriation A-11090 has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.

5. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
6. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-11090 will be **cancelled** unless this determination is successfully contested.
7. Landowners with a legal interest in the land under this appropriation may:
 - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-11090.
 - B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) **by 5:00 P.M. on February 23, 2026. No filing fee is required.**
