**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-13839**

WATER DIVISION 1-F

1. Records on file in the Department of Water, Energy, and Environment (Department) show that surface water appropriation A-13839 is held by **Laurie J. McPherrin Harms**.
2. The Department has received information that **Steve Harms** may have a spousal interest in appropriation A-13839.
3. Appropriation A-13839 has a priority date of **October 28, 1975**, and authorizes use of water for irrigation on **99.0 acres**, described below. Water may be diverted from **the North Fork of the Big Nemaha River** at a point of diversion located on the right bank of the stream in the **SE¹/₄SE¹/₄** of **Section 29, Township 05 North, Range 11 East of the 6th P.M. in Johnson County**. The maximum diversion rate shall not exceed **1.41 cubic feet** per second (cfs).

4. Based on information received and records reviewed, the Department has determined that Appropriation A-13839 has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.
5. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
6. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-13839 will be **cancelled** unless this determination is successfully contested.

7. Landowners with a legal interest in the land under this appropriation may:
- A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-13839.
 - B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) **by 5:00 P.M. on April 23, 2026. No filing fee is required.**
