**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-14930**

WATER DIVISION 2-B

1. Records on file in the Department of Water, Energy, and Environment (Department) show that land appurtenant to surface water appropriation A-14930 is owned by **Philip Stollberg, Douglas L. and Jolene M. Paasch and Larry and Cynthia Stollberg.**
2. Appropriation A-14930 has a priority date of **May 5, 1977,** and authorizes use of water for irrigation on **120 acres,** described below. Water may be diverted from **Pebble Creek** at points of diversion located on both banks of the stream in the **N¹/₂SW¹/₄** of **Section 27, Township 20 North, Range 06 East of the 6th P.M. in Dodge County.** The maximum diversion rate shall not exceed **1.71 cubic feet** per second (cfs) from all points of diversion.

3. Based on information received and records reviewed, the Department has determined that Appropriation A-14930 has not been used for irrigation for **more than five consecutive years,** as required by Nebraska law.
4. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04.**
5. Pursuant to **Neb. Rev. Stat. § 46-229.02,** this Notice serves as preliminary notification that Appropriation A-14930 will be **cancelled** unless this determination is successfully contested.
6. Landowners with a legal interest in the land under this appropriation may:
 - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-14930.

B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) **by 5:00 P.M. on May 1, 2026. No filing fee is required.**
