

**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-16272**

WATER DIVISION 2-B

1. Records on file in the Department of Water, Energy, and Environment (Department) show that surface water appropriation A-16272 is held by **John Wisnieski**.
2. Appropriation A-16272 has a priority date of **February 21, 1984**, and authorizes use of water for irrigation on **30.0 acres**, described below. Water may be diverted from **a tributary to Pebble Creek** at a point of diversion located on the south bank of the stream in the **NE¹/₄NW¹/₄** of **Section 17, Township 20 North, Range 05 East of the 6th P.M. in Dodge County**. The maximum diversion rate shall not exceed **0.43 cubic feet per second (cfs)**.

3. Based on information received and records reviewed, the Department has determined that Appropriation A-16272 has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.
4. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
5. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-16272 will be **cancelled** unless this determination is successfully contested.
6. Landowners with a legal interest in the land under this appropriation may:
 - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-16272.

B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) **by 5:00 P.M. on April 3, 2026. No filing fee is required.**
