**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-16373**

WATER DIVISION 2-B

1. Department records show that Surface Water Appropriation A-16373 is held by **Daniel H. and Jeannette A. Niewohner**.
2. Appropriation A-16373 has a priority date of **April 17, 1985**, and authorizes use of water for irrigation on **181.3 acres**, described below. Water may be diverted from **Pebble Creek** at a point of diversion located on the west bank of the stream in the **SW¹/₄SW¹/₄** of **Section 21, Township 20 North, Range 06 East of the 6th P.M. in Dodge County**. The maximum diversion rate shall not exceed **2.59 cubic feet per second (cfs)**.

3. Based on information received and records reviewed, the Department has determined that Appropriation A-16373 has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.
4. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
5. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-16373 will be **cancelled** unless this determination is successfully contested.
6. Landowners with a legal interest in the land under this appropriation may:
 - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-16373.
