**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-17755B**

WATER DIVISION 2-B

1. Records on file in the Department of Water, Energy, and Environment (Department) show that surface water appropriation A-17755B is held by **John P. and Dail E. Diedrichsen**.
2. Appropriation A-17755B has a priority date of **March 22, 1999**, and authorizes use of water for irrigation on **8.1 acres**, described below. Water may be diverted from **Pebble Creek** at a point of diversion located on east bank of the stream in the **NE $\frac{1}{4}$ SW $\frac{1}{4}$** of **Section 05, Township 19 North, Range 07 East of the 6th P.M. in Dodge County**. The maximum diversion rate shall not exceed **0.12 cubic foot feet** per second (cfs).

3. Based on information received and records reviewed, the Department has determined that Appropriation A-17755B has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.
4. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
5. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-17755B will be **cancelled** unless this determination is successfully contested.
6. Landowners with a legal interest in the land under this appropriation may:
 - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-17755B.

B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) **by 5:00 P.M. on April 1, 2026. No filing fee is required.**
