**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE  
OF SURFACE WATER APPROPRIATION A-2428B**

WATER DIVISION 1-F

1. Records on file in the Department of Water, Energy, and Environment (Department) show that surface water appropriation A-2428B is held by **the Erna F. Gilster Revocable Trust**.
2. Appropriation A-2428B has a priority date of **July 16, 1934**, and authorizes use of water for irrigation on **17.25 acres**, described below. Water may be diverted from **the North Fork of the Big Nemaha River** at points of diversion located in the **NE $\frac{1}{4}$ SE $\frac{1}{4}$**  of **Section 14, Township 05 North, Range 10 East of the 6<sup>th</sup> P.M. in Johnson County**. The maximum diversion rate shall not exceed **0.25 cubic feet** per second (cfs) from all points of diversion.

3. Based on information received and records reviewed, the Department has determined that Appropriation A-2428B has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.
4. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
5. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-2428B will be **cancelled** unless this determination is successfully contested.
6. Landowners with a legal interest in the land under this appropriation may:
  - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-2428B.
  - B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) **by 5:00 P.M. on April 1, 2026. No filing fee is required.**
