**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-3061**

WATER DIVISION 2-B

1. Records on file in the Department of Water, Energy, and Environment (Department) show that surface water appropriation A-3061 is held by **Beverly Eggers**.
2. Appropriation A-3061 has a priority date of **December 19, 1939**, and authorizes use of water for irrigation on **45.9 acres**, described below. Water may be diverted from **the Elkhorn River** at a point of diversion located on the left bank of the stream in the **SW¹/₄SW¹/₄** of **Section 02, Township 24 North, Range 05 West of the 6th P.M. in Antelope County**. The maximum diversion rate shall not exceed **0.33 cubic feet** per second (cfs).

3. Based on information received and records reviewed, the Department has determined that Appropriation A-3061 has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.
4. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
5. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-3061 will be **cancelled** unless this determination is successfully contested.
6. Landowners with a legal interest in the land under this appropriation may:
 - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-3061.
 - B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) **by 5:00 P.M. on April 1, 2026. No filing fee is required.**
