**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-8769A**

WATER DIVISION 2-B

1. Department records show that Surface Water Appropriation A-8769A is held by **Lynn R. and Amy K. Selting**.
2. Appropriation A-8769A has a priority date of **August 23, 1956**, and authorizes use of water for irrigation on **20.7 acres**, described below. Water may be diverted from **Cedar Creek** at points of diversion located on both banks of the stream in the ~~NE¼NE¼~~ of **Section 03, Township 23 North, Range 06 West of the 6th P.M. in Antelope County**. The maximum diversion rate shall not exceed **0.30 cubic feet** per second (cfs) from all points of diversion.

Township 23 North, Range 06 West of the

3. Based on information received and records reviewed, the Department has determined that Appropriation A-8769A has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.
4. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
5. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-8769A will be **cancelled** unless this determination is successfully contested.
6. Landowners with a legal interest in the land under this appropriation may:
 - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-8769A.
 - B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) **by 5:00 P.M. on March 26, 2026. No filing fee is required.**
