ORDER OF PROVISIONAL RELINQUISHMENTS (CANCELLATION) PREL-9024 AND PREL-9025

AND NOTIFICATION FOR REASSIGNMENT REA-9026

OF WATER APPROPRIATIONS D-828A AND D-828B

WATER DIVISION 1-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriations D-828A and D-828B are held by the Bridgeport Irrigation District (District) as described on **Attachment A**.
2. On June 26, 2018 landowner Irving Franklin signed a relinquishment form for land under D-828B.
3. On June 14, 2021, the Bridgeport Irrigation District (District) filed a provisional relinquishment PREL-9024, relinquishing the right to irrigate the 13 acres land under appropriation D-828B assigned to said parcel.
4. On June 14, 2021, the District and landowners filed PREL-9025, relinquishing the right to irrigate 45 acres land under appropriation D-828A.
5. On June 14, 2021 the District filed in the Department Notification for Reassignment REA-9026, to assign the 58 acres of appropriation D-828A and D-828B previously relinquished.
6. On August 30, 2021, the District corrected filed PREL-9024 to include their signature and acknowledgment of the landowners request to relinquish in full all claims to the right to divert and apply water to the property appurtenant to appropriation D-828B.

ORDER

IT IS HEREBY ORDERED:

1. A portion of the water under appropriation D-828A and D-828B for use upon the land described in **Attachment B** and shown on map number 20612 is CANCELLED.
2. The Department acknowledges REA-9026 to assign portions of water under appropriations D-828A and D-828B for use upon the land described on **Attachment B** and shown on map number 20612.
3. Appropriation D-828B through reassignment REA-9026 will now be served by the Belmont Canal and be shown in Department records as part of D-828A.

4. All terms and conditions of previous orders for appropriation D-828 remain in effect unless specifically changed by this Order.
5. The land depicted on map number 20612 only represents the change of location of acres under appropriation D-828A through PREL-9024, PREL-9025 and REA-9026.
6. A listing of land entitled to irrigation under appropriation D-828A is specified on **Attachment C**.
7. A summary of the appropriations' acres and grants as a result of the District's filings in the Department before and after this Order is provided on **Attachment D**.
8. **Attachments A, B, C, and D**, and map number 20612 are hereby made a part of this Order.
9. Pursuant to *Neb. Rev. Stat. § 46-229.04(5)* the District may assign, within 5 years of the Order of Cancellation by the Department, the relinquished portion of an appropriation.
10. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following:
  - A. Receiving approval prior to taking any action that changes the location of the point of diversion, a transfer of the location of the place of use, a relinquishment of a portion of the appropriation, the type of use, or the type of appropriation.
  - B. Notify the Department of Natural Resources of any reassignment of relinquished portions of an appropriation.
  - C. Comply with all relevant notices and orders of the Department.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations and any orders issued by the Director of the Department of Natural Resources may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for five consecutive years may result in cancellation of the appropriation.
