ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-2263BR

WATER DIVISION 2-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-2263BR is held by RIOVISTA, LLC.
2. Appropriation A-2263BR has a priority date of March 18, 1932, and authorizes the use of water for irrigation of the 100.74 acres of land described below. The water may be diverted from the North Loup River at points of diversion located in the SW<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub> and the NE<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub> of Section 36, Township 23 North, Range 21 West of the 6<sup>th</sup> P.M. in Blaine County and the SW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub> of Section 30, Township 23 North Range 20 West in Loup County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 140 acres irrigated at a maximum combined rate of 0.72 cfs from all points of diversion.
