APPROVAL OF PETITION MIP-9708 TO CHANGE THE PUMPSITE LOCATION FOR

PERMITS TO CONDUCT WATER CSW-19823 AND CSW-19824

AND MAP NUMBER 21079

WATER DIVISION 1-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that conduct surface water permits CSW-19823 and CSW-19824 are held by The Central Nebraska Public Power and Irrigation District (CNPPID).
2. Permits CSW-19823 and CSW-19824 authorize CNPPID to conduct water from the Platte River and Kingsley Reservoir through Plum Creek for irrigation of 132 acres of land.
3. The source of the water to be conducted under CSW-19823 is from the Platte River via the headgate of the Tri-County Canal located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 08, Township 13 North, Range 29 West of the 6th P.M. in Lincoln County into the E-65 Lateral located in Section 01, Township 08 North, Range 23 West of the 6th P.M. in Gosper County.
4. The source of the water to be conducted under CSW-19824 is from Kingsley Reservoir via the headgate of the Tri-County Canal located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 08, Township 13 North, Range 29 West of the 6th P.M. in Lincoln County into the E-65 Lateral located in Section 01, Township 08 North, Range 23 West of the 6th P.M. in Gosper County.
5. On July 13, 2022, Devin Brundage, on behalf of CNPPID, filed petition MIP-9708 requesting a change in the location of the pumpsite for CSW-19823 and CSW-19824 and map number 21079.
6. Petition MIP-9708 requests to move the location of the pumpsite to right bank of the stream in the NE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 32, Township 08 North, Range 21 West of the 6<sup>th</sup> P.M in Gosper County.

ORDER

IT IS HEREBY ORDERED that MIP-9708 for conduct water permits CSW-19823 and CSW-19824 and map number 21079 are APPROVED.

1. CSW-19823 and CSW-19824 shall be shown in the Department's records authorizing the use of water to irrigate 132 acres of land described below and depicted on map number 21079, which is made a part of this Order. The water may be released from E-65 Lateral at a maximum rate of 2.10 cubic feet per second (cfs) (942 gallons per minute), entering Plum Creek in the SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 20, Township 08 North, Range 22 West, and withdrawn from a pump site located on the right bank of the stream in the NE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 32, Township 08 North, Range 21 West of the 6<sup>th</sup> P.M. in Gosper County as indicated on map number 21079. Water withdrawn from

Plum Creek under conduct water CSW-19823 and CSW-19824 shall not exceed exceed 1.89 cfs (848 gallons per minute).
