ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-18243

WATER DIVISION 1-D

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18243 is held by the Neal R. and Carol A. Sell Trusts.
2. Appropriation A-18243 has a priority date of May 19, 2004 and authorizes the use of water for irrigation of the 44.6 acres of land described below. The water may be diverted from the Big Blue River at points of diversion located on the right bank of the stream in the SW<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub> of Section 07, Township 11 North, Range 03 East of the 6<sup>th</sup> P.M. in Seward County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 0.64 cfs from all points of diversion.

3. On September 27, 2022, Beth Schulz, on behalf of the Neal R. Sell Trust and herself, Carol Sell and Timothy Sell filed a Relinquishment of Water Appropriation, REL-7409, in the office of the Department relinquishing the right to divert water under appropriation A-18243 for use upon the land described above, conditional on approval of surface water transfers for A-9876, A-10636, A-12020 and A-14360.

IT IS HEREBY ORDERED appropriation A-18243 is CANCELLED.
