APPROVAL OF APPLICATION A-19875 AND MAP NUMBER 21097

WATER DIVISION 1-D

BACKGROUND

- On September 14, 2022, David A. Meints filed in the Department of Natural Resources (Department) application A-19875 for a Permit to Appropriate Water.
- 2. On October 14, 2022, David A. Meints filed in the Department map number 21097 showing land proposed to be irrigated under application A-19875.
- 3. Construction has been completed.

ORDER

IT IS HEREBY ORDERED that application A-19875 and map number 21097 are APPROVED subject to the following limitations and conditions:

1. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19875 as depicted on map number 21097 which is made a part of this Order.

- 2. Appropriation A-19875 has a priority date of September 14, 2022, and authorizes the appropriator the use of 40 acre-feet annually from Meints Reservoir (storage appropriation A-19874) from a pump site located in the SE¼NE¼ of Section 04, Township 05 North, Range 03 East of the 6th P.M. in Saline County, as depicted on map number 21097.
- 3. This appropriation will be limited to the land irrigated and the amount of water beneficially used on an annual basis. Such amount shall not exceed 40 acre-feet per annum.
- 4. Only the land shown on map number 21097 may be irrigated under appropriation A-19875 unless a change is authorized by subsequent Order of the Department.

- 5. If, during the course of construction of the irrigation project, it is determined that there is a difference in the number and/or location of acres from the approved map, an amended project map may be filed for an equal or lesser number of acres prior to the beneficial use investigation deadline. The Department, at its sole discretion, must determine that the change from the original map remains within the original project concept and does not violate any rules and/or statutes and will not harm another appropriator. The amended map may then be approved by Order of the Department for an equal or lesser number of acres of land or amount of water than originally granted.
- 6. A measuring device approved by the Department is required.
- 7. The appropriator must comply with all relevant statutes. The statutes include, but are not limited to, the following:
 - A. Notify the Department of any change in ownership or address.
 - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
- 8. The appropriation is not considered perfected until water has been beneficially applied for the purpose stated in this Order. The water appropriated under A-19875 must be beneficially used by September 1, 2025.
- 9. After September 1, 2025, a field investigation will be conducted to determine the lands where water has been beneficially applied.
 - A. If the entire appropriation is found to have water beneficially applied, a Certificate of Perfected Appropriation will be issued by the Department for A-19875.
 - B. If a portion of the appropriation is found to have had water beneficially applied within the original project concept the Department may, at its discretion, modify the project map and land listing to represent the conditions found during the field investigation. The number of acres and diversion rate determined by the Department will not exceed what is granted by this Order. A Certificate of Perfected Appropriation specifying the final number of acres, location of acres and diversion rate will be issued by the Department for A-19875.
 - C. If no portion of the appropriation is found to have water beneficially applied, the Department will issue an Order of Cancellation in Full for A-19875.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Order may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for more than five consecutive years may result in cancellation of the appropriation.

This appropriation is not a guarantee that water will be available. Nebraska law gives priority to senior appropriations. This appropriation may be closed if there is insufficient water to satisfy senior appropriations. If in the future you are not able to divert sufficient amounts of water, and if there are junior appropriations upstream, you may call for water by contacting your local field office.
