# ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-15277

#### WATER DIVISION 1-D

#### BACKGROUND

- 1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-15277 is held by Adam and Jessica Roth.
- 2. A portion of appropriation A-15277 provides supplemental water to land already approved for irrigation under natural flow appropriation A-9052. The remaining portion of appropriation A-15277 is located on land not covered by an additional surface water appropriation.
- 3. Appropriations A-15277, right ID 2915, and A-15277, right ID 2916, have a priority date of June 16, 1978, and authorize the use of 15.0 acre-feet of water annually from La Rue Farms Reservoir (storage appropriation A-15276) from a pump site located in the NE4NW4 of Section 19, Township 09 North, Range 04 East of the 6th P.M. in Seward County.
- 4. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-15277, right ID 2915, and is not covered by an existing appropriation.

5. The following land is authorized to be irrigated under surface water appropriation A-15277, right ID 2916, and provides supplemental irrigation under natural flow appropriation A-9052.

6. The Department has received information concerning the use of surface water appropriation A-15277 that indicates the appropriation has not been used for its required purpose for more than five consecutive years.

- 7. On August 30, 2022, the Department issued a Notice of Preliminary Determination of Nonuse of appropriation A-15277. The Notice was displayed on the Department's website for over 30 days and was sent by certified mail to Adam and Jessica Roth, 2884 Yankee Hill Road, Milford, Nebraska 68405.
- 8. On October 3, 2022, the certified mailing to Adam and Jessica Roth at the abovementioned address was returned unclaimed.
- 9. On October 28, 2022, Deputy Johnny May of the Seward County Sheriff's Office personally delivered the Notice of Preliminary of Nonuse of appropriation A-15277 to Adam and Jessica Roth.
- 10. No contest of the Preliminary Determination of Nonuse was received in the Department.
- 11. The Department has determined that appropriation A-15277 has not been used for its required purpose for more than five consecutive years.
- 12. Nebraska Revised Statutes § 46-229.02 provides that an appropriation not used for a beneficial purpose for more than five consecutive years may be cancelled.

ORDER

IT IS HEREBY ORDERED appropriation A-15277 is CANCELLED.
