ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-8134

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-8134 is held by Daniel J. and Arlene J. Hans and the John O. Leece Family Trust.
2. Appropriation A-8134 has a priority date of September 19, 1955, and authorizes the use of water for irrigation of the 8.0 acres of land described below. The water may be diverted from Stevens Creek at a point of diversion located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 24, Township 10 North, Range 07 East of the 6th P.M. in Lancaster County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 140 acres irrigated at a maximum rate of 0.06 cfs.
