ORDER OF CANCELLATION IN PART OF WATER APPROPRIATION A-9675

AND APPROVAL OF MAP NUMBER 21187

WATER DIVISION 1-D

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-9675 is held by Patricia A. Vogel and Richard A. and Mary L. Frerichs.
2. Appropriation A-9675 has a priority date of December 29, 1958, and authorizes the use of water for irrigation of the 84 acres of land described below. The water may be diverted from the West Fork of the Big Blue River at a point of diversion located on the right bank of the stream in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 22, Township 09 North, Range 02 East of the 6th P.M. in Seward County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 1.20 cfs.

3. On March 27, 2023, Richard A. and Mary L. Frerichs filed relinquishment REL-7468, relinquishing the right to divert water under a portion of appropriation A-9675 to irrigate the 10.0 acres of land described below.

IT IS HEREBY ORDERED:

1. Part of appropriation A-9675 at the rate of 0.14 cfs for use upon the 10 acres of land described above is CANCELLED.

This appropriation is not a guarantee that water will be available. Nebraska law gives priority to senior appropriations. This appropriation may be closed if there is insufficient water to satisfy senior appropriations. If you are not able to divert sufficient amounts of water, you may call for water by contacting your local field office.
