ORDER OF PROVISIONAL RELINQUISHMENTS (CANCELLATION) PREL-9685 AND PREL-9686

#### AND NOTIFICATION OF REASSIGNMENT REA-9687

#### FOR WATER APPROPRIATIONS D-887 AND A-768

#### WATER DIVISION 1-A

#### BACKGROUND

- Records on file in the Department of Natural Resources (Department) show that surface water appropriation D-887, with a priority date of October 13, 1894, authorizes the Beerline Canal Company (BCC) to divert 14.19 cubic feet per second (cfs) from the North Platte River through the Beerline Canal at the headgate located in Section 24, Township 19 North, Range 49 West of the 6<sup>th</sup> P.M. in Morrill County for irrigation of 993 acres as summarized in Attachment A.
- 2. Water appropriation A-768 with a priority date of September 19, 1904, is a permit to divert water from Pathfinder Reservoir through the Beerline Canal for supplemental irrigation of lands covered by D-887 and storage water only to an additional 64 acres of land.
- 3. On March 28, 2023, BCC and individual landowners filed in the Department Provisional Relinquishment PREL-9685 to provisionally relinquish the right to irrigate portions of land under appropriation D-887 and Provisional Relinquishment PREL-9686 to provisionally relinquish the right to irrigate portions of land under appropriation A-768.
- On March 28, 2023, BCC filed Notification of Reassignment REA-9687 in the Department to reassign portions of appropriations D-887 and A-768 previously relinquished.

ORDER

IT IS HEREBY ORDERED:

- 1. A portion of the water under D-887 and A-768 for use upon the land described in **Attachment B** is CANCELLED.
- The Department acknowledges REL-9687 to reassign a portion of water under appropriations D-887 and A-768 for use upon the land described on Attachment B as shown on aerial photograph filed with REA-9687 and map number 21167.
- The aerial photograph and map number 21167 only represent the change of location of acres under appropriations D-887 and A-768 through provisional relinquishments PREL-9685 and PREL-9686 and reassignment REL-9687.

- 4. A listing of land entitled to irrigation under D-887 and A-768 is described in **Attachment C**.
- 5. A summary of the appropriations' acres and grants as a result of BCC's filings in the Department before and after this Order and the portions of BCC's appropriations that are available for future reassignment or transfer are summarized in **Attachment D**.
- 6. Attachments B, C and D and map number 21167 are hereby made a part of this Order.
- 7. All terms and conditions of previous orders for appropriations D-887 and A-768 remain in effect unless specifically changed by this Order.
- 8. Pursuant to Neb. Rev. Stat. § 46-229.04(5) BCC may assign, within 5 years of the Order of Cancellation by the Department, the relinquished portion of an appropriation.
- 9. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following:
  - A. Receiving approval prior to taking any action that changes the location of the point of diversion, a transfer of the location of the place of use, a relinquishment of a portion of the appropriation, the type of use, or the type of appropriation.
  - B. Notify the Department of Natural Resources of any reassignment of relinquished portions of an appropriation.
  - C. Comply with all relevant notices and orders of the Department.

#### ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations and any orders issued by the Director of the Department of Natural Resources may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for five consecutive years may result in cancellation of the appropriation.
