ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-2602

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-2602 is held by Erwin Kolterman Trust.
2. Appropriation A-2602 has a priority date of July 30, 1936, and authorizes the use of water for irrigation of the 119.2 acres of land described below. The water may be diverted from the North Fork of the Elkhorn River at points of diversion located in the SW<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub>, SE<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub> and NE<sup>1</sup>/<sub>4</sub>SE<sup>1</sup>/<sub>4</sub> of Section 15, Township 26 North, Range 02 West of the 6<sup>th</sup> P.M. in Pierce County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 254 acres irrigated at a maximum combined rate of 0.47 cfs from all points of diversion.
