APPROVAL OF PETITION VAR-10165 FOR LEAVE TO FILE AN APPLICATION

FOR A TEMPORARY PERMIT TO APPROPRIATE WATER

WATER DIVISION 2-C

BACKGROUND

- 1. On November 3, 2004, the Department of Natural Resources (Department) issued a formal moratorium on all new surface water appropriations in portions of the Upper Niobrara White Natural Resources District (UNWNRD). The moratorium included the Niobrara River Basin above the Mirage Flats diversion dam.
- 2. The Department's November 3, 2004, Order and the provisions of Neb. Rev. Stat. \$46-714(3)(n) allow for new surface water appropriations and increases in irrigated acres if the Department grants a variance and subsequently approves a permit for such new use.
- 3. On August 8, 2011, an integrated management plan (IMP) was adopted by Order of the Department, pursuant to *Neb. Rev. Stat.* § 46-718(2) for the UNWNRD.
- 4. On February 16, 2024, Wade Yada, on behalf of the Dawes County Road Department (Petitioner), filed Petition VAR-10165 for Leave to File an Application for a Permit to Appropriate Water. The proposed application is for a temporary permit to appropriate less than 10 acre-feet of water for the purpose of public road construction from the Niobrara River at a point of diversion located in the NEMNEM of Section 35, Township 29 North, Range 51 West of the 6th P.M. in Dawes County.
- 5. When filing a variance request, a project proponent must offer a clearly stated basis for such request and must offer sufficient good cause shown. Department of Natural Resources Rules for Surface Water, Title 457 Neb. Admin. Code Chapter 23 lists six circumstances that may be put forward as justification for granting a variance to apply for a new water use, in conjunction with an examination of good cause shown.

FINDINGS

- 1. As part of the surface water controls of the IMP adopted by the Department pursuant to Neb. Rev. Stat.§ 46-716(1) (b), the moratorium on issuing new surface water appropriations was continued.
- 2. The maintenance of roads constitutes a public safety issue.

3. The proposed application is for a temporary permit to appropriate less than 10 acre-feet of water for public road construction. The Petitioner asserts that water use is a necessary component of the construction project which addresses a public safety issue.

CONCLUSIONS

- 1. The proposed application is for a temporary permit for less than $10 \ \mathrm{acre-feet}$ of water.
- 2. The proposed project addresses a public safety issue and the Petitioner has shown good cause, thereby meeting the requirements of Department of Natural Resources Rules for Surface Water 457 Neb. Admin. Code Chapter 23.
- 3. Petition VAR-10165 should be granted.

ORDER

IT IS HEREBY ORDERED:

- 1. Petition VAR-10165 for Leave to File an Application for a Permit to Appropriate Water is GRANTED.
- 2. This Order granting leave to file or consider an application for a new surface water appropriation within a moratorium or stay area pursuant to petition VAR-10165 shall be in effect for one year from the date this Order is signed.
- 3. The granting of petition VAR-10165 shall not bind the Director to approve any application to which it relates, or in any way be used as evidence of prejudice for the Director's future decisions concerning the specific approval requirements of such application. Allowance of leave to file an application does not negate the necessity to meet the specific approval requirements for an appropriation.
