ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-13187

WATER DIVISION 2-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-13187 is held by Gary V. and Jo E. Mathiesen, Co-Trustees.
2. Appropriation A-13187 with a priority date of September 3, 1974, authorizes the use of water for irrigation of the 15 acres of land described below. The water may be diverted from a tributary to New York Creek at a point of diversion located on the left bank of the stream in the NW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub> of Section 18, Township 19 North, Range 11 East of the 6<sup>th</sup> P.M. in Washington County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.22 cfs.

3. The Department has received information concerning the use of surface water appropriation A-13187 that indicates the appropriation has not been used for its required purpose for more than five consecutive years.
4. On February 7, 2024, the Department issued a Notice of Preliminary Determination of Nonuse of appropriation A-13187. The Notice was delivered by certified mail to Gary V. and Jo E. Mathiesen, 18147 County Road P10, Herman, Nebraska 68029; and Matt Mathiesen, 18147 County Road P10, Herman, Nebraska 68029.
5. No contest of the Preliminary Determination of Nonuse was received in the Department.
6. The Department has determined that appropriation A-13187 has not been used for its required purpose for more than five consecutive years.
7. *Nebraska Revised Statutes* § 46-229.02 provides that an appropriation not used for a beneficial purpose for more than five consecutive years may be cancelled.

ORDER

IT IS HEREBY ORDERED appropriation A-13187 is CANCELLED.
