ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-13807

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-13807 is held by Adam and Kaylyn Venteicher and BVV Exchange LLC, formerly B & V Exchange LLC.
2. Appropriation A-13807 has a priority date of September 16, 1975, and authorizes the use of water for irrigation of the 320 acres of land described below. The water may be diverted from Willow Creek at a point of diversion located on the right bank of the stream in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 01, Township 25 North, Range 03 West of the 6th P.M. in Pierce County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 4.57 cfs.

On April 8, 2024, Adam and Kaylyn Venteicher filed Relinquishment of Water Appropriation, REL-10226, in the office of the Department relinquishing the right to divert water under a portion of land located in the SW $\frac{1}{4}$ of said legal description appurtenant to appropriation A-13807 for use upon the land described above conditional on approval of application A-19989.
4. On April 10, 2024, Steven P. Vinton, Manager for B & V Exchange LLC, filed Relinquishment of Water Appropriation, REL-10230, in the office of the Department relinquishing the right to divert water under a portion of land located in the NW $\frac{1}{2}$ of said legal description appurtenant to appropriation A-13807 for use upon the land described above conditional on approval of application A-19990.
