APPROVAL OF APPLICATION A-19944 AND MAP NUMBER 21217

WATER DIVISION 1-F

BACKGROUND

- On August 28, 2023, Randall F. and Amy Gyhra and Derek Gyhra filed in the Department of Natural Resources (Department) application A-19944 for a Permit to Appropriate Water and map number 21217 showing land proposed to be irrigated under this application.
- 2. The applicants agreed to following conservation measures specified by the Nebraska Game and Parks Commission pursuant to the Nongame and Endangered Species Conservation Act Neb. Rev. Stat. § 37-807, as described in NGPC Project No. DNR24003 concurrence letter dated February 26, 2024, as shown in Attachment A.

ORDER

IT IS HEREBY ORDERED that application A-19944 and map number 21217 are APPROVED subject to the following limitations and conditions:

1. The following land is authorized to be irrigated under surface water appropriation A-19944 as depicted on map number 21217 which is made a part of this Order.

- 2. Appropriation A-19944 has a priority date of August 28, 2023, and authorizes the appropriator the use of 3.94 cubic feet per second (cfs) (1768 gallons per minute) of water for irrigation of the 276.0 acres of land described above. The water may be diverted from a tributary to Balls Branch at points of diversion located on the right bank of the stream in the SE4SW4 and the SE4SE4of Section 23, Township 02 North, Range 10 East of the 6th P.M. in Pawnee County, as depicted on map number 21217.
- 3. The rate that water may be diverted shall not exceed one cfs for every 70 acres irrigated not to exceed 3.94 cubic feet per second from all points of diversion nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to three acre-feet per acre of land on which water is actually and beneficially applied.
- Only the land shown on map number 21217 may be irrigated under appropriation A-19944 unless a change is authorized by subsequent Order of the Department.
- 5. If during the course of construction of the irrigation project it is determined that there is a difference in the number and/or location of acres from the approved map, an amended project map may be filed for an equal or lesser number of acres prior to the beneficial use investigation deadline. The Department, at its sole discretion, must determine that the change from the original map remains within the original project concept and does not violate any rules and/or statutes and will not harm another appropriator. The amended map may then be approved by Order of the Department for an equal or lesser number of acres of land or amount of water than originally granted.
- 6. A measuring device approved by the Department is required. Contact the Lincoln Field Office before acquiring a measuring device to ensure the device will be acceptable.
- 7. Within two weeks after the first diversion of water under this application the appropriator must file written notice with the Lincoln Field Office informing the Department that the first irrigation diversions have occurred. The written communication must be signed by the appropriator and may be delivered by U.S. Postal Mail, hand delivered or sent via e-mail attachment to the Lincoln Field Office Supervisor.
- 8. The appropriator must comply with all relevant statutes. The statutes include, but are not limited to, the following:
 - A. Notify the Department of any change in ownership or address.
 - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).

- 9. The appropriator must comply with the following deadlines:
 - A. The appropriator must proceed diligently with the construction unless interrupted by some unavoidable and natural cause.
 - B. The appropriation is not considered perfected until water has been beneficially applied for the purpose stated in this Order. The water appropriated under A-19944 must be beneficially used by September 1, 2027.
- 10. After September 1, 2027, a field investigation will be conducted to determine the lands where water has been beneficially applied.
 - A. If the entire appropriation is found to have water beneficially applied, a Certificate of Perfected Appropriation will be issued by the Department for A-19944.
 - B. If a portion of the appropriation is found to have had water beneficially applied within the original project concept the Department may, at its discretion, modify the project map and land listing to represent the conditions found during the field investigation. The number of acres and diversion rate determined by the Department will not exceed what is granted by this Order. A Certificate of Perfected Appropriation specifying the final number of acres, location of acres and diversion rate will be issued by the Department for A-19944.
 - C. If no portion of the appropriation is found to have water beneficially applied, the Department will issue an Order of Cancellation in Full for A-19944.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Order may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for more than five consecutive years may result in cancellation of the appropriation.

This appropriation is not a guarantee that water will be available. Nebraska law gives priority to senior appropriations. This appropriation may be closed if there is insufficient water to satisfy senior appropriations. If in the future you are not able to divert sufficient amounts of water, and if there are junior appropriations upstream, you may call for water by contacting your local field office.
