ORDER OF CANCELLATION IN PART,

APPROVAL OF EXPEDITED TRANSFER EXT-10503 AND MAP NUMBER 21468

FOR WATER APPROPRIATION A-14097

WATER DIVISION 1-D

BACKGROUND

- 1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-14097 is held by Shirley Sloup and R. Scott and Glenda M. Sloup.
- 2. Appropriation A-14097 has a priority date of March 15, 1976, and authorizes the use of water for irrigation of the 62.0 acres of land described below. The water may be diverted at a point of diversion located on the right banks of Sloup Reservoir (storage permit A-13827) in the SE¼NE¼ of Section 36, Township 12 North, Range 02 East of the 6th P.M. in Seward County. Water diverted shall not exceed the 5.17 acre-feet per annum.

Sloup and himself, filed application EXT-10503 for a permit for an expedited transfer of the location of use for 41.1 of the 62.0 acres under surface water appropriation A-14097 and map number 21468 showing the land proposed to be irrigated under appropriation A-14097 through transfer EXT-10503.
- 4. On August 26, 2024, Shirley Sloup and R. Scott and Glenda M. Sloup filed REL-10224 relinquishing a portion of the water under appropriation A-14097, for use on the land described below.

ORDER

IT IS HEREBY ORDERED:

- 1. Part of surface water appropriation A-14097 for the 20.9 acres of land described above is CANCELLED.
- 2. Application EXT-10503 for a permit for an expedited transfer of the location of use and map number 21468 are APPROVED.
- 3. Appropriation A-14097 through transfer EXT-10503 authorizes the use of water to irrigate 41.1 acres of land described below and depicted on map number 21468, which is made a part of this Order. The water may be diverted from Sloup Reservoir at a point of diversion located in the SE4NE4 of Section 36, Township 12 North, Range 02 East of the 6th P.M. in Seward County, as depicted on map number 21468. Water diverted shall not exceed the 5.17 acre-feet per annum.

- 4. All terms and conditions of previous orders for appropriation A-14097 remain in effect unless specifically changed by this Order.
- 5. The appropriator must comply with all relevant statutes. These relevant statutory requirements include, but are not limited to, the following:
 - A. Notify the Department of any change in ownership or address.
 - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
 - C. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Order may cause cancellation of part or all of this appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use an appropriation for more than five consecutive years may result in cancellation of the appropriation.
