ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-13725

WATER DIVISION 2-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-13725 is held by the Stevan A. Andersen Revocable Trust, the Martha L. Andersen Revocable Trust and Andrew S. Andersen.
2. Appropriation A-13725 with a priority date of August 11, 1975, authorizes the use of water for irrigation of the 192 acres of land described below. The water may be diverted from a tributary to Big Papillion Creek at a point of diversion located on the left bank of the stream in the SW¹/₄SE¹/₄ of Section 27, Township 18 North, Range 10 East of the 6th P.M. in Washington County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 2.74 cfs.

3. The Department has received information concerning the use of surface water appropriation A-13725 that indicates the appropriation has not been used for its required purpose for more than five consecutive years.
4. On November 7, 2024, the Department issued a Notice of Preliminary Determination of Nonuse of appropriation A-13725. The Notice was delivered by certified mail to Stevan A. Andersen, Stevan A. Andersen Revocable Trust, 21948 County Road 20, Arlington, Nebraska 68002; Martha L. Andersen, Martha L. Andersen Revocable Trust, 21948 County Road 20, Arlington, Nebraska 68002; and Andrew S. Andersen, 7768 County Road P-17, Arlington, Nebraska 68002.
5. No contest of the Preliminary Determination of Nonuse was received in the Department.
6. The Department has determined that appropriation A-13725 has not been used for its required purpose for more than five consecutive years.


7. *Nebraska Revised Statutes* § 46-229.02 provides that an appropriation not used for a beneficial purpose for more than five consecutive years may be cancelled.
