# ORDER OF PROVISIONAL RELINQUISHMENTS (CANCELLATION)

#### PREL-11444 THROUGH PREL-11448

AND NOTIFICATION OF REASSIGNMENTS REA-11449 THROUGH REA-11453

OF WATER APPROPRIATIONS D-477, D-477R, A-936, A-15828 AND A-15829

#### WATER DIVISION 2-D

#### BACKGROUND

- 1. Records on file in the Department of Water, Energy , and Environment (Department) show that surface water appropriations D-477, D-477R, A-936, A-15828 and A-15829 are held by the White River Irrigation District (District). The appropriations allow the District to divert water from the White River and Souther Reservoir for irrigation as summarized on Attachment A.
- 2. On September 16, 2025, the District and individual landowners filed in the Department Provisional Relinquishment PREL-11444 through PREL-11448 to provisionally relinquish the right to irrigate portions of land under appropriations D-477, D-477R, A-936, A-15828 and A-15829 respectively and Notification of Reassignment REA-11449 through REA-11453 to reassign portions of the appropriations previously relinquished.

#### ORDER

## IT IS HEREBY ORDERED:

- 1. A portion of the water under D-477, D-477R, A-936, A-15828 and A-15829 from the White River and Souther Reservoir for use upon the land described in **Attachment B** is CANCELLED.
- 2. The Department acknowledges REA-11449 through REA-11453 to reassign portions of water under D-477, D-447R, A-936, A-15828 and A-15829 for use upon the land described in **Attachment B** as shown on map number 21674.
- 3. The land depicted on map number 21674 only represents the change of location of acres under D-477, D-447R, A-936, A-15828 and A-15829 through relinquishments PREL-11444 through PREL-11448 and reassignments REA-11449 through REA-11453.
- 4. All terms and conditions of appropriations D-477, D-477R, A-936, A-15828 and A-15829 remain in effect unless specifically changed by this Order.
- 5. Lands entitled to water under appropriations D-477, D-447R, A-936, A-15828 and A-15829 are described in **Attachment C**.

- A summary of the appropriations' acres and grants as a result of the 6. District's filings in the Department before and after this Order, and the portions of the District's appropriations that are available for future reassignment or transfer are summarized in Attachment D.
- Attachments B, C and D are hereby made a part of this Order. 7.
- 8 . Pursuant to Neb. Rev. Stat. § 46-229.04(5) the District may assign, within 5 years of the Order of Cancellation by the Department, the relinquished portion of an appropriation.
- 9. A project map showing all lands included under the appropriations for the White River Irrigation District must be filed in the Department within 6 months of this Order.
- 10. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following:
  - Receiving approval prior to taking any action that changes the location of the point of diversion, a transfer of the location of the place of use, a relinquishment of a portion of the appropriation, the type of use, or the type of appropriation.
  - Notify the Department of any reassignment of relinquished portions of an appropriation.
  - Comply with all relevant notices and orders of the Department. С.

#### ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations and orders issued by the Department may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for five consecutive years may result in cancellation of the appropriation.
