ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-10784

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Water, Energy, and Environment (Department) show that surface water appropriation A-10784 is held by **Monte L. and Rhonda M. Rainforth.**
2. Appropriation A-10784 with a priority date of **March 4, 1966,** authorizes the use of water for irrigation of the **95.3 acres** of land described below. The water may be diverted from **the Elkhorn River** at points of diversion located on the left bank of the stream in the **NW¹/₄NW¹/₄ and SW¹/₄NW¹/₄ of Section 03, Township 28 North, Range 11 West of the 6th P.M. in Holt County.** The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every **70 acres** irrigated at a maximum combined rate of **1.36 cfs** from all points of diversion.

3. The Department has received information concerning the use of surface water appropriation A-10784 that indicates the appropriation has not been used for its required purpose for more than five consecutive years.
4. On January 22, 2026, the Department issued a Notice of Preliminary Determination of Nonuse of appropriation A-10784. The Notice was delivered by certified mail to Monte L. and Rhonda M. Rainforth, 49563 870 Road, O'Neill, Nebraska 68763.
5. No contest of the Preliminary Determination of Nonuse was received in the Department.

6. The Department has determined that appropriation A-10784 has not been used for its required purpose for more than five consecutive years.
7. Nebraska Revised Statutes § 46-229.02 provides that an appropriation not used for a beneficial purpose for more than five consecutive years may be cancelled.

ORDER

IT IS HEREBY ORDERED appropriation A-10784 is **CANCELLED**.
