ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-15321

WATER DIVISION 2-F

BACKGROUND

1. Records on file in the Department of Water, Energy, and Environment (Department) show that surface water appropriation A-15321 is held by **Darrel Hoelsing**.
2. Appropriation A-15321 with a priority date of **August 15, 1978**, authorizes the appropriator the use of **5.7 acre-feet** of water annually from Hoelsing Brothers Reservoir (storage appropriation A-15308) for irrigation on **120 acres**, described below. Water may be diverted from a **pump site located in the W¹/₂NE¹/₄ of Section 26, Township 33 North, Range 01 West of the 6th P.M. in Cedar County.**

3. The Department has received information concerning the use of surface water appropriation A-15321 that indicates the appropriation has not been used for its required purpose for more than five consecutive years.
4. On December 9, 2026, the Department issued a Notice of Preliminary Determination of Nonuse of appropriation A-15321. The Notice was delivered by certified mail to Darrell Hoelsing, 2509 Dorian Drive, Yankton, South Dakota 57078.
5. No contest of the Preliminary Determination of Nonuse was received in the Department.
6. The Department has determined that appropriation A-15321 has not been used for its required purpose for more than five consecutive years.
7. Nebraska Revised Statutes § 46-229.02 provides that an appropriation not used for a beneficial purpose for more than five consecutive years may be cancelled.

ORDER

IT IS HEREBY ORDERED appropriation A-15321 is **CANCELLED**.
