Updates

Nebraska

- Update and Current Conditions (Jim Ostdiek)
 - 19.96% of the state was covered by some degree of drought compared to
 98.32% the previous year.
 - No administration had occurred on the Niobrara River since October 1st, 2023.
 - Precipitation was about one half of an inch lower than the average since October 1st, 2023.
 - Box Butte Reservoir was at 7,306 AF on October 1st, 2023, 1,233 AF higher than the previous year.
 - At the time of the meeting, Box Butte Reservoir was at 18,581 AF, 5,372 higher than the previous year.
 - Niobrara River at the Wyoming-Nebraska state line was starting to see some runoff with the warmer temperatures. Current flow was around 11 cfs.
- NRD Activities (Andy Pedley)
 - Upper Niobrara-White NRD had entered into a contract to update their groundwater model. NeDNR was working with the NRD to update their Integrated Management Plan (IMP), expanding the plan to the entire district. The changes to NRD rules resulting from the IMP update were expected to be minor.
- NPS and USGS Niobrara National Scenic River Hydrogeologic Study and Modeling (Andy Pedley)
 - NeDNR and USGS were working on a groundwater model. All of the USGS documentation was expected to be finished by the end of the year.

Wyoming

- Update and Current Conditions (Wray Lovitt)
 - The Wyoming porting of the Niobrara Basin had recently received about 18-24 inches of snow. The flows at the state line had increased.
 - More precipitation was expected in the coming weeks, making for a good year in terms of moisture.
- Update of applications in the basin (Michelle Hubbard)
 - Since the last meeting, three stock/domestic wells had been permitted.
 - One Irrigation/stock well and one Irrigation well had been approved.

Other Topics

Bill Wilson asked if the holder of a surface water right had to be a Nebraska resident.
 Tom Riley responded he did not believe so, but he would check. Mr. Riley assured Mr.
 Wilson that the laws of the State were adequate to protect the waters of the State from interstate transfers which were not in the interest of Nebraska.
