- **1.** Welcome and Open Meetings Act: Miller noted that a copy of the Open Meetings Act was available in the meeting room.
- **2. Publication of Meeting Notices:** The NDNR published a public notice (Attachment B) of the PBC meeting in the Grand Island Independent on June 11, 2015, the North Platte Telegraph on June 11, 2015, and the Scottsbluff Star Herald on June 9, 2015.
- **3. Agenda Modifications:** No revisions were made to the agenda (Attachment C).
- 4. Approval of April 13th, 2015, PBC Meeting Minutes:

Motion: To approve the April 13th, 2015, PBC meeting minutes (Attachments D).

Schellpeper motioned to approve and Horn seconded. Motion passed with all ayes.

- 5. Budget Update (NDNR)
 - **A. Operations:** Sharp led the group in a discussion of the PBC budget summary spreadsheets (Attachment E). Sharp reported that the operations budget has had no changes since the previous meeting.

B. Studies: Sharp reported that contract numbers were added to the contracts per request of the PBC. The contracts are also being merged into one file so they can be reviewed more efficiently.

Action: Sharp will work on merging the PBC contract files.

C. Second three-year increment funding: NDNR did revise Exhibit 1 of the amendment to the Platte Basin Water Project Coalition interlocal cooperative agreement to include the dollar amount of the Phase I Conservation Study to the studies budget. Payments were made on North Dry Creek in the amount of \$3,000 leaving a balance of \$17,160. Sharp noted that to close-out the North Dry Creek budget we need to know if more invoices are expected or if all invoices have been received. Orchard Alfalfa spent their funding in years 1-3 on the recent October through March payment request. In years 4-6, Sharp confirmed with Mark Czaplewski of CPNRD that Orchard Alfalfa has \$20,722.74 remaining to spend on their project.

Proposals for funding for four spring and summer of 2015 excess flow groundwater recharge projects were proposed to the PBC members. Schellpeper referred to the project proposal memos handed out to the members (Attachments F and G). The total new cost for the recharge projects involving the Platte Valley, Western, and Suburban Irrigation Districts is \$25,000. This proposal would require discussion on how NET funds may be reallocated due to TPNRD funds for years 4-6 already being budgeted for. The acre-foot cap for the Elwood Reservoir and E-65 Canal recharge project was increased from 10,000 to 15,000 for the spring/summer 2015 excess flows, resulting in a request for an additional \$213,200 in funding.

Motion: To approve the funding request from TPNRD, SPNRD, and NDNR for Suburban, Western, and Platte Valley recharge projects. Funding for TPNRD's portion of these projects is approved on the condition that there are NET funds available at the end of years 4, 5, and 6. Total project cost of \$25,000 with Suburban Irrigation District Project \$2,000 by TPNRD, \$3,000 by NDNR; Western Irrigation District Project \$4,200 by TPNRD, \$1,800 by SPNRD, \$9,000 by NDNR; Platte Valley Irrigation District \$2,000 by TPNRD, \$3,000 by NDNR.

Woodward motioned to approve and Horn seconded. The motion passed with all ayes.

Motion: To approve the funding request from TBNRD and NDNR for the spring/summer 2015 Elwood Reservoir and E-65 Canal recharge projects. Total project costs of \$213,200 with \$106,600 by TBNRD, and \$106,600 by NDNR.

Reynolds motioned to approve and Woodward seconded. The motion passed with all ayes.

6. Project Updates

- **A. N-CORPE:** Miller reported that the current estimated timeline for construction of the north pipeline is 2016. State-revolving funds are being sought, but legislative action is required to change statute and allow use of these funds. New language is expected to be introduced in the next legislative session. Easements are completed for the six miles of county road and work on the easements with landowners on approximately four miles should wrap up in about six weeks.
- **B.** Orchard Alfalfa: Woodward reported that in May they did divert water due to excess flows, and also filed transfer water rights on approximately 3,000 of the 4,000 acres that are to be transferred back to the river.
- C. J-2 Regulating Reservoir: Schellpeper referred attendees to the quarterly update in the meeting packet (Attachment H). Issues were identified in that the anticipated costs are likely to increase and they plan to deliver an updated opinion of the costs sometime this year. Schneider offered that the increase is primarly due to the changing construction bidding climate in that more companies were looking for work when the initial cost estimate was made. It was asked if the project costs could be capped. Schneider stated monetary commitment could be reduced but that would also reduce the percentage of benefits through PRRIP that the State would receive.
- **D. North Platte NRD Lease:** At the preceding Upper Platte Basin-Wide IMP Annual Meeting, Berge reported on the Cow Camp project for which the NPNRD leased approximately 350 acres of farmland and how the historic irrigated crop water use of those acres was calculated so as to be credited toward NPNRD's obligations (Attachment I). The next steps in the project are to finalize documentation of the project and submit an amended recharge permit application to NDNR.
- **E.** Tri-Basin Phase II Augmentation: At the preceding Upper Platte Basin-Wide IMP Annual Meeting, Little reported that the second augmentation well was put in place (Attachment J). The second well was run for a few days this spring in order to test it.

F. South Platte NRD Temporary Retirement Agreement: Glanz reported that SPNRD is monitoring water use at the temporary retirement location.

7. Project Requests:

A. North Platte NRD Retirement Agreement: Berge referred to the retirement project funding proposal memo in the meeting packet (Attachment K). These are groundwater retirement projects that NPNRD is seeking reimbursement for. Miller mentioned that it is important to ensure that this proposed reimbursement is legal and that the legislature would view it as money spent. Berge stated he didn't need action on Proposal #1 today and the group agreed to consider Proposal #2 for action while waiting on a determination on Proposal #1 from the NDNR staff.

Motion: To approve Proposal #2 as outlined in the NPNRD memo (\$75,815.25 x 3), while waiting for NDNR staff to address Proposal #1.
Mintken motioned to approve and Horn seconded. The motion passed with all ayes.

Action: NDNR staff will look into Proposal #1 of NPNRD's Groundwater Retirement Package and report back to the group at the August 6, 2015, PBC meeting.

- **8. Public Comments:** There were no public comments.
- **9. Adjourn:** The meeting adjourned at 3:04 p.m.

- **1.** Welcome and Open Meetings Act: Miller noted that a copy of the Open Meetings Act was available in the office.
- **2. Publication of Meeting Notices:** The NDNR published a public notice (Attachment B) of the PBC meeting in the Grand Island Independent on April 4, 2015, the North Platte Telegraph on April 4, 2015, and the Scottsbluff Star Herald on April 7, 2015.
- **3. Agenda Modifications:** No revisions were made to the agenda (Attachment C).
- 4. Approval of December 1st, 2014; December 19th, 2014; January 12th, 2015; and February 19th, 2015, PBC Meeting Minutes:

<u>Motion</u>: To approve the December 1st, 2014; December 19th, 2014; January 12th, 2015; and February 19th, 2015, PBC meeting minutes (Attachments D-G).

Woodward motioned to approve and Schellpeper seconded. Motion passed with all ayes.

- 5. Budget Update (NDNR)
 - **A. Operations:** Sharp and Schellpeper led the group in a discussion of the PBC budget summary spreadsheets (Attachment H) Sharp reported that the operations budget had been updated to reflect the 2015 liability insurance payments. A projected operations budget for years 4-6 has also been added to the summary. A

few updates have been made to the years 1-3 budget spreadsheet, but total dollars have not changed since the last meeting. NDNR and TPNRD will make sure that NDNR has received TPNRD's most recent Master Plan. NDNR and NPNRD will work together to determine what steps remain in the process of finalizing the contracts for the NPNRD lease/recharge and Grandview permanent retirement projects. There have not been any revisions to the years 4-6 budget spreadsheet, but Sharp noted that there is \$7.7 million left to be committed.

B. Studies: A budget pre-estimate for the Robust Review has been added to the studies budget spreadsheet.

Action: Sharp will go back to ensure that the approved budget amounts for the studies are the same as the contracted amounts in the PBC budget summary spreadsheets.

Action: Woodward will send out the first invoice for the OA/FA study in June 2015 so that the NRDs can decide if this payment needs to be made during the current fiscal year or the next.

C. Second three-year increment funding: Shellpeper discussed the draft amendment to the interlocal cooperation agreement between the Platte Basin Water Project Coalition and the representative NRDs and NDNR (Attachment I).

<u>Motion</u>: To approve the amendment to the Platte Basin Water Project Coalition interlocal cooperative agreement, subject to a revision to include the dollar amount of the Phase I Conservation Study to the studies budget in Exhibit 1 of the amendment.

Berge motioned to approve and Miller seconded. The motion passed with all ayes.

Action: NDNR will revise Exhibit 1 of the amendment to the Platte Basin Water Project Coalition interlocal cooperative agreement to include the dollar amount of the Phase I Conservation Study to the studies budget.

Action: NDNR will route the signature page of the approved amendment to the Platte Basin Water Project Coalition interlocal cooperative agreement to the NRD managers for signature.

6. Project Updates

A. N-CORPE: Miller reported that the N-CORPE wells are currently shut down and, at this point, there are no plans to have the wells running again for the rest of 2015. At their April 2015 meeting, the N-CORPE board will consider a request to sell water to Bostwick Irrigation District. Project land is gradually being reseeded into native grasses. The current estimated timeline for construction of the north pipeline is 2016.

- **B.** Orchard Alfalfa: Woodward reported that the last of the contracted work on the project was completed in early April 2015. The transfer water rights and excess flow permits have been completed. Czaplewski reminded Schellpeper that the Orchard Alfalfa contract needs to be amended. Schellpeper noted that the draft amendment for the contract is being reviewed by but will be sent to CPNRD soon. *Action:* NDNR will send a draft amendment for the Orchard Alfalfa contract to CPNRD.
- C. J-2 Regulating Reservoir: Schellpeper noted that the group received a copy of the most recent quarterly report for the J-2 project in their meeting handouts (Attachment J). Steinke added that the land aquisition process is confidential and little information will be released until final deals have been made. Agreements have been made to allow access to private property for field tests and a new task order has been signed with the consultants to begin work on the 50% design. Don Kraus recently met with Senator Deb Fischer to discuss her concerns related to the project and land acquisition. The Jeffery Island feasibility study determined this option to be 250% more expensive and more complex in regard to permiting and engineering design. - **D. North Platte NRD Lease:** Berge reported that NPNRD is continuing productive discussions with downstream stakeholders who have concerns about the project. Budgeted money for pit construction will be carried over to the next fiscal year.
- **E. Tri-Basin Phase II Augmentation:** Thorburn reported that both augmentation wells are in place and they are waiting on North Dry Creek to get some water so that the wells can be run.
- **F.** South Platte NRD Temporary Retirement Agreement: Reisdorff reported that the contract for this project is in place and the first payment to the property owner was made at the end of 2014.

Action: SPNRD will send Sharp a copy of the contract for the SPNRD temporary retirement agreement.

Recharge Project

Spring 2014 Project Update:

TBNRD, NDNR, and CNPPID entered into Contract #771 (attached) on June 6, 2014 and amended on June 30, 2014, for the diversion of excess Platte River flows for the purposes of groundwater recharge. Excess flows were available before and after irrigation season. 13,237 AF of water was diverted into the reservoir before spring. Approximately 1,763 AF of water was diverted into the reservoir in late fall 2014. The funding for spring diversions was approved at the August 2014 PBC meeting. The late fall diversion funding required approval of \$68,757.30 or \$34,378.50 for each party. As of February 26, 2015, all funds have been spent. The contract has expired as of December 31, 2014.

Fall/Winter 2014-2015 Project Update:

TBNRD, NDNR, and CNPPID entered into Contract #800 (attached) on December 10, 2014 and amended on December 18, 2014, for the diversion of excess Platte River flows in the Fall/Winter of 2014-2015 for the purpose of groundwater recharge. Excess flows were available after irrigation season. Up to 10,000 AF of water were diverted into the Elwood or E65 Canal reservoir. Totals were split evenly between the TBNRD and NDNR, totaling \$410,114.50 or \$205,057.25 for each party for the Fall/Winter 2014-2015 diversions. As of March 31, 2015, all funds for the project have been spent.

Request New Funds:

TBNRD, NDNR, and CNPPID amended Contract #800 (attached) on May 22, 2015, for the diversion of excess Platte River flows for the purpose of groundwater recharge. Up to 5,000 of additional acre feet of water are contracted for diversion into the Elwood or E65 Canal reservoir. Totals are to be split evenly between the TBNRD and NDNR, totaling \$213,200 or \$106,600 for each party.

Phelps Canal Diversion Project Update:

Platte River Recovery Implementation Program (PRRIP), NDNR, and CNPPID entered into Contract #799 (attached) on November 20, 2014, for the diversion of excess Platte River flows for the purpose of groundwater recharge. Excess flows were available after irrigation season ended. Up to 4,000 AF of water were diverted into the Phelps Canal. Totals were split evenly between the PRRIP and NDNR, totaling \$112,320 or \$56,160 for each party. As of March 31, 2015, all funds have been spent for the project. The contract expires on December 31, 2015.

PBC:

The total new cost for the E65 Canal and Elwood Reservoir projects detailed in the amendment to contract #800 and being submitted to the PBC for total payment is \$213,200 or \$106,600 for TBNRD & \$106,600 for NDNR NET funds.

Excess Flows

Request:

This is a request for funds for an additional groundwater recharge of excess flows into Canals similar to those that took place in the spring of 2011. Details of the groundwater recharge projects can be found in the February 29, 2011, memo from the Department to the PBHEP administrators, therefore, project details will not be repeated here; rather, this memo will provide a brief overview of the Excess Flow Diversions and project costs. The Department, SPNRD and TPNRD request that the Platte Basin Coalition administrators take action to support this request for funding.

2011 Project Successes:

In the spring and fall of 2011, multiple irrigation canals in the Platte Valley were used to divert river flows for the purpose of recharging groundwater aquifers and to assist with mitigation of anticipated flood flows. The Department and area NRDs supported and participated in these projects. The details of the 2011 projects, supporting arguments, and basic agreements are described in the Department's February 28, 2011, memo. The 2011 projects resulted in the diversion of 141,911 acre-feet of water at a cost of approximately \$550,000. As a result of these projects, approximately 36,000 acre-feet of water will reach the Platte River through accretions over the next 50 years. Suburban Irrigation District

TPNRD, NDNR, and Suburban Irrigation Company entered into Contract #586 (attached) on December 3, 2012, for the diversion of excess South Platte River flows. A task order was entered on May 13, 2015 for the irrigator to divert the excess flows of the North Platte River. The funding requires approval for a total of \$5,000 or \$3,000 for NDNR and \$2,000 for TPNRD.

Western Irrigation District

SPNRD, TPNRD, NDNR, and Western Irrigation Company entered into Contract #587 (attached) on November 14, 2012, for the diversion of excess South Platte River flows. A task order was entered into on May 11, 2015 for the irrigator to divert the excess flows from the South Platte River. The funding requires approval for a total of \$15,000 or \$9,000 for NDNR and \$1,800 for SPNRD and \$4,200 for TPNRD.

Platte Valley Irrigation District

TPNRD, NDNR, and Platte Valley Irrigation Company entered into Contract #588 (attached) on November 9, 2012, for the diversion of excess South Platte River flows. On May 13, 2015, a task order was created for the irrigator to divert excess flows of the North Platte River. The funding requires approval for a total of \$5,000 or \$3,000 for NDNR and \$2,000 for TPNRD.

PBC:

The total new cost for the three (3) projects detailed in contracts (586, 587 and 588) and being submitted to the PBC for payment is \$25,000. (see Table 1 for details)

Budget – All Twin Platte Natural Resources District's NET funds have been committed. The funds from TPNRD are \$8,200 short for the proposed irrigation district projects. A transfer of NET funds between each NRD is needed to approve NET funding for the Suburban, Western and Platte Valley Irrigation District Excess Flow projects. In keeping with Section 6.02.5.2 of the PBC Interlocal Cooperation Agreement, Twin Platte NRD requests the release of PBC water acquisition funds currently budgeted to other NRD's to cover the \$12,300 NET funds and the \$8,200 NRD matching funds.

J-2 Regulating Reservoirs Project

Report Period: March, April, May 2015

The purpose of this Quarterly Report is to provide a general summary of the work performed for the J-2 Regulating Reservoirs Project (Project) during March, April, and May of 2015. This does not include details of all the subtasks performed. The summary of work is organized into the following general categories of work:

- General Project Management and Implementation Tasks
- Permitting Activities
- Land Purchase Activities
- Water Rights Petition Filing
- Engineering Tasks

General Project Management and Project Implementation Tasks

- The team continued to coordinate through recurring teleconferences.
- RJH renewed the yearly subscription to maintain a file-share site for use by the Project Team to share and store Project information.
- Central maintained a Project website to provide information to the public.
- The Team continued to hold topic-specific coordination meetings to support various aspects of land purchasing, permitting, and engineering.
- RJH finalized a contract with Central for project management, engineering, and design services through 50 percent design of the Project.
- Kleinschmidt finalized a contract with Central for FERC permitting services through filing of the license amendment, including development of a biological opinion and programmatic agreement for historic properties.
- RJH continued to update overall Project schedule based on changes to land acquisition and permitting progress.
- Central established contracts for cultural resource survey work.
- Central established a contract with a Nebraska wetland specialist to perform wetland delineation and stream assessments.
- Responded to Senator Deb Fischer's requests for project information and met with Senator Fischer's staff.
- Presented Project information to two Central Nebraska farmer and agronomist groups.



Permitting Activities

- Based on comments received on the ICD and in preliminary agency meetings, continued to revise and refine study plans for wetlands, water quality, and RTE species. Agreed to develop the Cultural Resource Study Plan separate from above study plans.
- Participated in preliminary agency meetings with NDNR (Dam Safety group and Water Measurement group) and USACE wetlands permitting.
- Began compiling the previously-studied project alternatives in response to meeting with USACE. USACE noted that they would require documentation to support that the preferred alternative (the J-2 Project) is the least damaging practicable alternative (LDPA).
- Continued Phase I cultural resource field survey (walking surveys).
- Began Phase II cultural resource field survey (excavations) concurrent with geotechnical explorations.
- Continued development of reports for on-site buildings to enable SHPO evaluation of eligibility for the national register of historic buildings.
- Met with National Parks Service trail representative to discuss Project's potential impacts to Oregon Trail ruts.
- Participated in a preliminary agency meeting with FERC in Washington D.C.
- Issued draft study plans for Wetlands and Water Quality to agencies for review.
 Decided that Central has performed sufficient studies to adequately characterize the presence of RTE species at the Project site.
- Scheduled meeting to discuss agency's preliminary review comments on study plans.

Land Purchase Activities

- Continue to negotiate in good faith for the purchase of J-2 Project lands.
- Continued to obtain legal opinions on approach and actions related to purchasing land for the Project.
- Received and reviewed a proposed access agreement from 5 landowners.
- Entered into an agreement with the 5 landowners noted above for temporary access to Project lands.
- Requested and obtained a second agreement for temporary access to Project lands owned by the 5 landowners noted above.

Water Rights Petition Filing

• No work was performed on this task.



Engineering Tasks

- Continued to monitor the groundwater levels at 22 monitoring well locations along the Phelps Canal and around the proposed reservoir areas.
- Performed a geologic desktop study and site reconnaissance, and mapped the site geology.
- Planned and began a geotechnical exploration consisting of two drill rigs and a backhoe working on site for approximately 4 weeks.
- Began geotechnical laboratory testing and data compilation.
- Continued to advance development of the concept to realign the road around the proposed reservoirs, specifically considering intersections and alignment relative to the embankment and a relocated Plum Creek.
- Completed developing concepts for new bridges needed over the Extended Supply Canal and the new alignment of Plum Creek.
- Continued hydrologic evaluations of Plum Creek (2-dimensional model), the Platte River, and the unnamed tributary. These evaluations are needed to identify the likely flows during infrequent and significant storm events such as the 100-year-storm and the Probable Maximum Precipitation.
- Continued hydraulic evaluation to support design and a Conditional Letter of Map Revision (CLOMR) for the Platte River Floodplain.
- Continued to refine hydraulic modeling of the canal to evaluate project operations and concepts.
- Began researching case histories of clay-lined reservoirs to evaluate potentiallyneeded concept adjustments.
- Began researching regulatory requirements for canal freeboard.
- Began topographic survey of Site using LiDAR techniques.
- Continued to update concepts for the canal, dams, and reservoirs.
- Began updating items, quantities, and developing and opinion of probable project costs for the updated concepts.

Tasks Anticipated for the Next Quarter

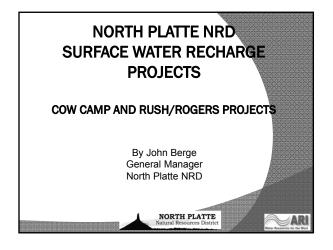
- Host a study plan comment meeting with regulatory agencies.
- Address agency comments and finalize plans for wetlands and water quality studies.
- Begin performing wetland delineation and stream assessments.
- Begin collecting water quality data in accordance with accepted study plans.
- Compile previously-studied Project alternatives and begin evaluation of the J-2 Project's environmental impact relative to other alternatives.

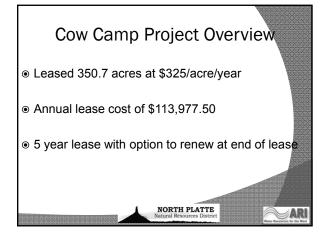


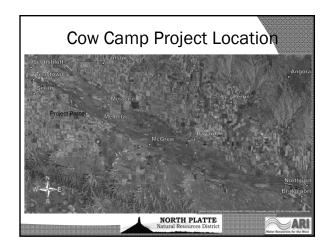
- Continue performing Phase I (walking assessments) of the cultural resource survey.
- Develop reports documenting the results of Phase I (walking surveys) and initial
 Phase II (excavations) cultural resource studies.
- Develop a Phase II study plan for cultural resources and submit to SHPO for review and comment.
- Begin preparations for Phase II field work for cultural resources studies.
- Begin developing FERC draft license amendment based on updated Project concept.
- Continue to pursue purchase of lands needed for Project.
- Complete the conceptual-level hydrologic and hydraulic evaluations of floodplains.
- Continue the hydraulic evaluation of canal and regulating reservoir system to support design including modifications to the canal freeboard and structures (i.e., siphon and flume).
- Continue development and needed adjustments for the road and bridge concepts.
- Continue to update the dam and reservoir concepts based on a review of case histories of similar projects.
- Complete an update the project concepts and costs based on changes to the Project since the spring of 2013.

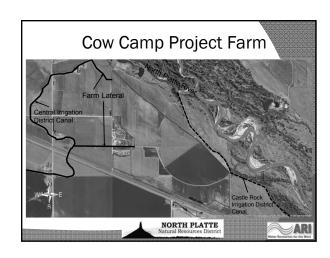
Potential Issues:

- As a result of potential permitting constraints and requirements, project concepts may need to be adjusted to reduce disturbance to portions of the J-2 Project Area.
- Based on the initial cultural resource studies performed this quarter, the extent of
 cultural resources that will need to be explored is much greater than suggested by
 previous studies. All walking surveys performed prior to 2015 will need to be
 redone and a significant archeological excavation may be needed. Some
 environmental studies may be delayed past initial estimates because of lack of
 access to Private land.
- The USACE is requiring documentation that the J-2 Project is the LDPA of the project concepts considered.
- Project components have been added to the Project and modified since RJH's feasibility review performed in late 2012. Additionally, the construction bidding climate has changed significantly from late 2012 and early 2013 when the engineer (RJH) developed their estimate of Project Costs. In RJH's opinion, the anticipated project costs are likely to increase. RJH plans to deliver an updated Opinion of Probable Project Costs in mid-2015.

Subject: North Platte NRD Proposal for Funding of Groundwater Retirement Package

This proposal describes three permanent groundwater retirement agreements between the North Platte NRD and, respectively, Shirley Hardt (one agreement) and Matt Tighe (two agreements), for which the North Platte NRD desires to obtain funding from the Platte Basin Coalition, consistent with the provisions of the Coalition Interlocal Cooperative Agreement and budgets established for reimbursement. The North Platte NRD requests proportionate funding, for reimbursement of agreement acquisition costs, in the amount of the maximum available funds; the remaining cost proportion, as outlined below, represents the North Platte NRD's contribution to the projects.

Agreement Description

The North Platte NRD identified the Hardt and Tighe tracts for the permanent retirement of groundwater, which will result in a combined total accretion of 1,120 acre-feet to the North Platte River. All tracts of land will be converted to grass. The North Platte NRD funded the acquisition of the groundwater use on the three tracts at a combined total cost of \$4,029,637.50. The terms of the agreements spread payments over fifteen years.

The attached project reimbursement data sheets provides the following information: tract name, legal description of the property, agreement closing date, related depletion/accretion data, price paid for the retirement of groundwater, PBHEP project type (as described in the PBHEP Trial Protocol), depletion zone, and the requested cost contribution breakdown, calculated according to reimbursement proposal 1. More detailed documentation may be provided on request. If reimbursement funding is approved through PBC, the North Platte NRD will provide to DNR the additional documentation necessary to complete the reimbursement transaction.

Reimbursement Proposal 1 (NPNRD preference)

As of the date of this proposal, the <u>uncommitted</u> Platte Basin Coalition budget for the remaining three-year increment for the North Platte NRD is \$1,904,003. A full 60% reimbursement request of the total value of the retirement agreements, as calculated according to the PBHEP Trial Protocol guidelines, would equal a total of \$2,417,782.50. This quantity exceeds the total funding available to the North Platte NRD in this three-year budget term. As a result, the North Platte NRD requests reimbursement of the maximum amount allowable under the PBHEP guidelines, up to the total \$1,904,003 available. If the irrigation retirement agreement package described in this document is approved for reimbursement as proposed, the balance remaining to the NRD in this budget term will be \$0, except for \$221,197.00 already allocated for future surface water lease/recharge (Cow Camp) reimbursements.

If approved, the North Platte NRD proposes to set up a sub-account with the Nebraska Community Foundation, under the existing Financial Management Agreement between the PBC parties and the Foundation, executed in 2012. Annual reimbursement requests for payments made on each agreement would be handled through the Foundation.

Reimbursement Proposal 2 (alternate)

If the Coalition does not decide favorably on the above-described reimbursement proposal, then the North Platte NRD requests reimbursement for payments made to date on the three retirement agreements. Total payments to date equal \$126,358.75. At 60% reimbursement, the North Platte NRD requests a total of \$75,815.25 in PBC funding for payments made. If the Coalition approves this reimbursement quantity, the total uncommitted funds remaining to the North Platte NRD for the remainder of the budget period would be \$1,828,187.75.

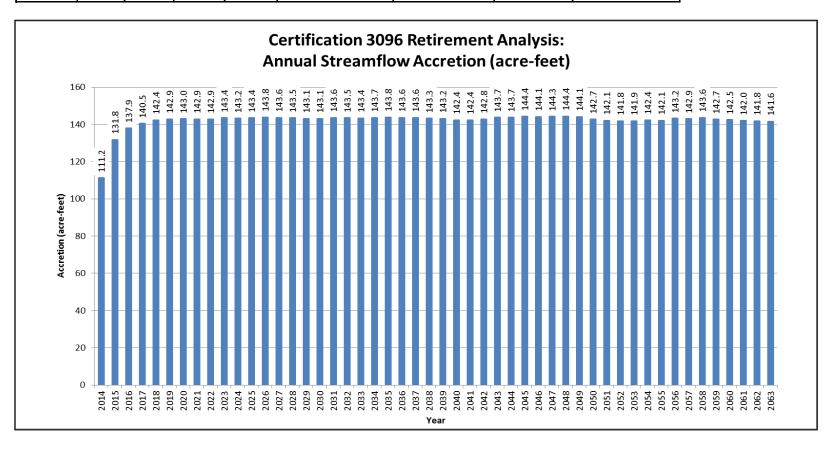

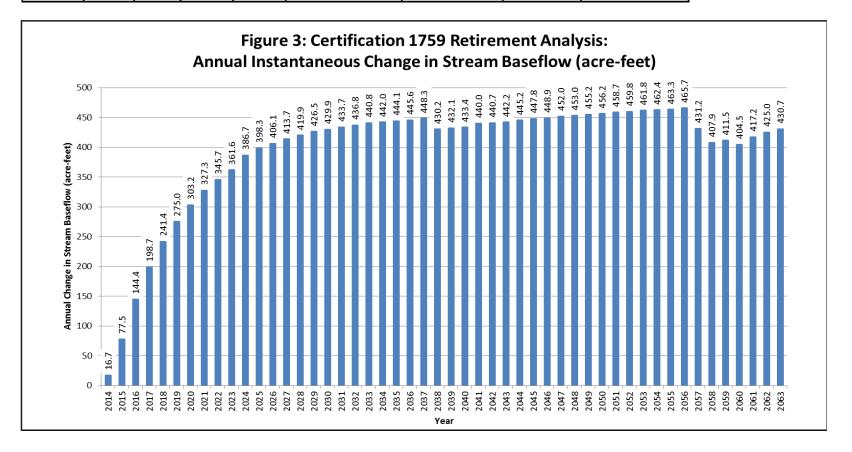

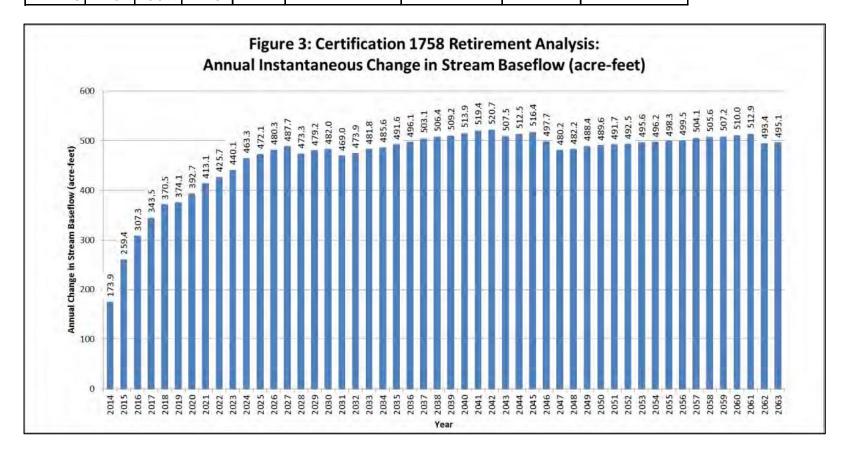
