# 5. BUDGET UPDATE (NEDNR)

# A. GENERAL UPDATES (Attachment E)

i. YEARS 4-6; NET BUDGET CLOSEOUT

Meyer reported on the NET Closeout Table, which is a representation of all of the money from years 4-6 that was spent (*ATTACHMENT F*). Meyer reported that the budget closeout will be slated for approval once NeDNR receives more information from the NET about the land form.

ii. YEARS 7-9

Schellpeper reported that Budget Years 7-9 have gone unchanged but will require updating after new obligations and funding requests stemming from the 12/3 PBC meeting are approved.

- iii. Studies
  - a. CONSERVATION STUDY INVOICE (CONTRACT #1153)

Meyer reported on two Conservation Study invoices (*ATTACHMENTS G & H*). Meyer reported that Invoice 20-2650 totals \$19,340 with the NeDNR portion accounting for \$9,670 and CPNRD, TBNRD, and TPNRD will have a portion of \$3,223.33 each. Invoice 20-2661 totals \$13,055. The NeDNR portion is \$6,527.50. CPNRD, TBNRD, and TPNRD will have a portion of \$2,175.83 each.

**MOTION:** To approve the two contract invoices from the Flatwater Group for data collection and the development of the final project report related to the Conservation Study with NeDNR paying 50% of each invoice and CPNRD, TBNRD, and TPNRD equally splitting the remaining 50% of each invoice.

Schellpeper reported on how the current contract with The Flatwater Group should be extended to the end of 2021 with no additional funding, due to the COVID-19 pandemic causing the cancelation of the workshop where there would have been a final presentation and a chance for the incorporation of feedback.

**MOTION:** To extend Contract #1153 with the Flatwater Group until the end of 2021, with no additional funding.

# **B.** New obligations/ Funding Requests

i. TBNRD's WATER CONSERVATION INCENTIVE PROGRAM (CONTRACT #1021)

Thorburn reported on a memo describing how TBNRD will use already-allocated funds for the Water Conservation Incentive Program, which Schellpeper clarified will meet the objectives of the Water Resources Cash Fund by increasing groundwater recharge (*ATTACHMENT I*).

**MOTION:** To approve TBNRD's Water Conservation Incentive Program.

- Vogt motioned. Berge seconded.

- Water Conservation Incentive Program approved with all ayes.
  - *ii.* NPNRD BUDGET CHANGE REQUEST

Berge reported on a budget proposal memo in which NPNRD will not be asking for new money but will seek to return unspent money to be redistributed among the Upper Platte NRDs (*ATTACHMENT J*). The proposal will seek to redistribute \$219,000 of Year 9 funds.

**<u>MOTION</u>**: To approve the NPNRD budget change request.

  - *iii.* TPNRD STREAMFLOW AUGMENTATION PIPELINE (NCORPE) (CONTRACT #778) Miller reported on a memo seeking to use remaining available funds for the Streamflow Augmentation Pipeline (NCORPE) Project (ATTACHMENT K).

**MOTION:** To approve the use of remaining funding for TPNRD's Streamflow Augmentation Pipeline (NCORPE) Project.

- Schellpeper motioned. Vogt seconded.
- Streamflow Augmentation Pipeline (NCORPE) Project funding approved with all ayes.
  - *iv.* CPNRD PROPOSAL FOR FUNDING OF THREE CONSERVATION EASEMENTS
     Vogt discussed a memo describing CPNRD's Three Conservation Easements
     totaling 353.2 acres with 245.37 af returning to the Platte River (ATTACHMENT L).
     Vogt clarified that the in the table in the memo, one of the categories should be
     "Current 50 Year ac/ft" instead of "Previous 50 Year ac/ft". NeDNR clarified that
     CPNRD will be using the same conservation easement format that they have used
     in the past for this reimbursement, which is compatible with the PBC Funding
     Protocol.

**<u>MOTION</u>**: To approve the CPNRD Proposal for Funding of Three Conservation Easements.

- Schellpeper motioned. Thorburn seconded.
- Proposal for funding request approved with all ayes.

## 6. APPROVAL OF HDR TO COMPLETE THE WATERSMART DROUGHT FUNDING GRANT APPLICATION

Kelly reported on a memo that described HDR's scope of work and the progress related to the application creation for the Water SMART Drought Contingency Plan that will meet the Bureau of Reclamation submission deadline of January, 6, 2021 (*ATTACHMENT M*).

**MOTION:** To approve HDR to complete the WaterSMART Drought Funding grant application.

- Vogt motioned. Schellpeper seconded.
- WaterSMART Drought Funding grant application contract with HDR approved with all ayes.

## 7. DISCUSSION OF LB-148

Kelly reported on LB-148, which requires certain entities that use certain tax dollars to hold a separate budget meeting where the public needs to be informed about what budget information is approved (*ATTACHMENT N*). LB-148 could relate to the PBC. If it does, a separate meeting would

likely need to be scheduled in April 2021 to coincide with when the PBC normally holds its annual budget meeting. Schellpeper added that LB-148 applies to entities that use occupation tax. In the case of the PBC the only entity utilizing the occupation tax is the TPNRD. Schellpeper stated that NeDNR is still continuing to interpret LB-148 and would like NRD feedback and will keep NRDs updated.
