## 6. Budget Update

## General Updates

Years 7-9 and Years 10-12

Jennifer Schellpeper, NeDNR, reported that the group is nearing the end of the one-year extension, June 30, 2022. \$10 million dollars remain to be spent by that date. Agenda Attachment A (Minutes Attachment D) has more details.

If any NRD has a project that can be completed by that date, they should submit it to the group for approval. Projects need to fit within the ILCA and WRCF agreement and management goals.

Yet to be determined is what Nebraska Environmental Trust money may carry-over to the next period/fiscal year. Further, Shelly Meyer, NeDNR, reminded the group that \$3.3 million will be coming for Years 10-12.

Lyndon Vogt, CPNRD, might have a project, but they will need to check the Unified Plan to see how the two may accommodate each other and fit within the timeline.

John Berge, NPNRD, contacted the NeDNR earlier in the week with a few projects that may qualify for some of these funds.

#### Studies

2023 Robust Review

Jennifer noted that the Western Water Use Management Model group has submitted a cost draft/proposal that the NeDNR received today. NeDNR will review the draft/proposal and have comments ready for the February 2022 meeting.

 Contract extension for NeDNR Contract #1153 – Phase III of the Soil and Water Conservation Measures Study Project. See Agenda Attachment B. (Minutes Attachment E).

Jennifer reminded the group that it is an extension in time not cost and that costs are split among the NRDs and the DNR for the conservation work.

**MOTION**: Invoice #21-2740: \$3,100 to The Flatwater Group with payments coming from Central Platte, Twin Platte, and Tri-Basin NRDs in the amount of \$516.66 each and a payment from the Nebraska DNR in the amount of \$1,555.02.<sup>1</sup>

HDR WaterSMART Grant

Ryan Kelly, NeDNR, reiterated that \$100,000 each will come from the NeDNR and the NRD once all the signatures have been received. The grant, focused on drought mitigation measures, will have two phases. According to the Bureau of Reclamation, qualified Phase 1 activities will be able to access grant monies before the official November 15, 2022 start date.

John Engel at HDR is our contact and will be working with Ryan. Ryan anticipates a work plan will be ready by the next PBC meeting. Task Force members should be identified by January's end and group members should expect an email detailing its' purpose and role.<sup>2</sup>

Jennifer reminded the group about the grant's connection to the Unified Plan and that it should also meet some of the drought plan requirements. She emphasized a coordinated approach.

  - A proposal for future expenditures related to on-going projects and waiting for a permit.
  - EPIC was assessed this year and will probably be again next fiscal year, so they will be requesting financial assistance.
- TBNRD--John Thorburn
  - Work with the Platte River Recovery Augmentation Wellfield project is nearly completed. All pipelines have been laid, the 5<sup>th</sup> well was being drilled today, and powerlines should be done by the end of the year.
- SPNRD--Galen Wittrock
  - None at this time.
- NeDNR--Jennifer Schellpeper
  - The J-2 Water Service Agreement for 2023 will to be discussed and updated with CNPPID.<sup>3</sup>
  - The updated Upper Platte Decision Support System (DSS) page should be nearly complete, so that completing the annual excess flow permit application forms will be easier. Information provided in a prior year's application will be automatically pulled into the current year's application.

Members stated that Jeremy [Gehle] does a good job communicating with the NRDs.
