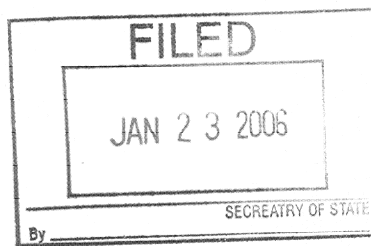

001 Banks of the River. For purposes of this Chapter, the banks of the river means the banks of the river which are the elevation of ground which confines the water at a level not exceeding flood stage, and is depicted by a line on maps produced by the Department of Natural Resources ("Department") using best available technical information, best available elevation information, and past and present observations of the river and adjacent lands.

002 Update of Boundary. The Department shall update the boundary determination whenever it determines that there has been a substantial change in the location of the banks of the river used for locating such boundary. For purposes of this section, a substantial change in the location of the banks of the river will be deemed to have occurred if a horizontal movement of greater than fifteen (15) yards has occurred from the current river bank line, and such change in the river bank line has been maintained for a period of at least two (2) years. Any member of the public may request the Department to review its boundary determination by submitting a petition requesting such review. Every petition must be accompanied by a representation made by the applicant that the boundary has undergone a substantial change as defined by this section. The Department may review its boundary determination on its own motion. The Department shall not be required to update the boundary determination more often than once every five (5) years.

003 Boundary - Douglas-Saunders County Game Refuge. The boundary of the Douglas-Saunders County Game Refuge is that line which is one hundred ten yards out from the banks of the stream as depicted on maps produced by the Department extending from the west line of Dodge County Saunders County east and south-east to the bridge across the Platte River, west of Venice, Nebraska, on U.S. Route No. 30A and State Route No. 92, along both sides of the Platte River, with all points of said line being perpendicular to the point on the bank of the Platte River to which it corresponds. This boundary establishes the outer edge of the Douglas-Saunders County Game Refuge regardless of any private ownership of the lands within said boundary.

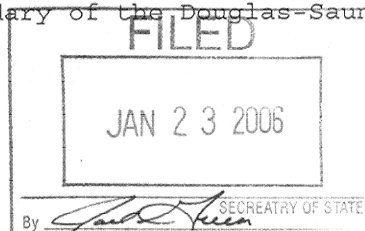
