The following information shall be submitted from this form, identified in an index and made a part hereof. Refer to Department Rules, Title 457, Chapter 16 for requirements A-E.

- 1. A description of the method of underground storage.
2. A summary of surface water appropriations, including the date of priority, the amount of the appropriation, the use, and the location of use.
3. Sufficient hydrologic information to identify the extent and scope of the underground water storage and naturally occurring ground water. This should include the results of any studies or models, and other information.
4. A description of the area served or to be served by the water stored underground.
5. If the application is for incidental underground water storage:
a. The historical record of surface water diversions.
b. A map showing the location and the number of acres actually served by surface water directly delivered by applicant within the last five years.
c. A map showing the location and the number of acres served by water stored underground and not served with surface water directly delivered by applicant within the last five years.
