ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-11661

WATER DIVISION 2-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-11661 is held by GGM, L.L.C.
2. Appropriation A-11661 has a priority date of March 5, 1969, and authorizes the use of water for irrigation of the 277.5 acres of land described below. The water may be diverted from the Middle Loup River at a point of diversion located on the left bank of the stream in the NW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 24, Township 15 North, Range 10 West of the 6<sup>th</sup> P.M. in Howard County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 3.96 cfs.
