ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-16046

WATER DIVISION 1-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-16046 is held by Verleen Vorderstrasse.
2. A search of the records of the Thayer County Register of Deeds indicates James Vorderstrasse, Bobbi Koss and Cindy Mesloh have an interest in the land appurtenant to A-16046.
3. Appropriation A-16046 has a priority date of January 12, 1982, and authorizes the use of water for irrigation of the 92.0 acres of land described below. The water may be diverted from Vorderstrasse Reservoir at a point of diversion located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 03, Township 01 North, Range 03 West of the 6th P.M. in Thayer County.
