ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-14232

WATER DIVISION 1-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that a portion surface water appropriation A-14232 located in the SW $\frac{1}{4}$ and E $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 05, Township 01 North, Range 13 East of the 6th P.M. in Richardson County is held the Lois J. Witter Revocable Trust.
2. Records on file in the Department of Natural Resources show that a portion surface water appropriation A-14232 located in the NW $\frac{1}{4}$ and NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 05, Township 01 North, Range 13 East of the 6th P.M. in Richardson County is held by Gregory L. and Janice L. Elbert.
3. Appropriation A-14232 has a priority date of May 20, 1976, and authorizes the use of water for irrigation of the 184.2 acres of land described below. Water may be diverted from the South Fork of the Big Nemaha River from a point of diversion located on the left bank of the stream in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 05, Township 01 North, Range 13 East of the 6th P.M. in Richardson County. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated at a maximum rate of 2.63 cfs (1,180 gallons per minute).


4. On July 16, 2020, Gregory L. and Janice L. Elbert filed a Relinquishment of Water Appropriation, REL-9012, in the office of the Department relinquishing the right to divert water under a portion of appropriation A-14232 for use upon the land described above.
5. On August 28, 2020, Nancy Wittwer, Trustee of the Lois J. Witter Revocable Trust filed a Relinquishment of Water Appropriation, REL-9053, in the office of the Department relinquishing the right to divert water under a portion of appropriation A-14232 for use upon the land described above.
6. Relinquishments REL-9012 and REL-9053 cover all of the land described above and are for relinquishment in full of the right to divert water under A-14232.
