ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-19574

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-19574 is held by Lathan Detlefsen, Janice Tesch and Charleen Sears.
2. Appropriation A-19574, with a priority date of November 27, 2017, authorizes the use of water for irrigation of the 195.2 acres of land described below. The water may be diverted from North Logan Creek at a point of diversion located on the left bank of the stream in the NW¹/₄SW¹/₄ of Section 23, Township 29 North, Range 03 East of the 6th P.M. in Cedar County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 2.79 cfs.



3. The approval of appropriation A-19574 was conditional upon the irrigation of the above land by September 1, 2020.
4. Department personnel performed a field investigation and determined the land approved for irrigation under appropriation A-19574 had not been irrigated by September 1, 2020.
5. *Nebraska Revised Statutes* § 46-229.02(7) provides for the cancellation of unused portions of surface water appropriations.

ORDER

IT IS HEREBY ORDERED appropriation A-19574 is CANCELLED.
