APPROVAL OF APPLICATION A-19874,

PLAN OF RESERVOIR 21089 AND MAP OF RESERVOIR 21091

WATER DIVISION 1-D

BACKGROUND

1. On September 14, 2022, David A. Meints filed in the Department of Natural Resources (Department) application A-19874 for a permit to impound water and plan of reservoir 21089 according to *Title 457 Neb. Admin. Code Chapter 11*.
2. Construction has been completed.

ORDER

IT IS HEREBY ORDERED Application A-19874, plan of reservoir 21089 and map of reservoir 21091 are APPROVED subject to the following limitations and conditions:

1. The source of water is a tributary to Plummers Branch.
2. The priority date is September 14, 2022.
3. The water to be stored under this appropriation is for the purpose of providing irrigation water for an irrigation project.
4. The amount of water that may be diverted shall not exceed 40 acre-feet per year to be stored in Meints Reservoir. This amount is based on a reservoir that stores 10.2 acre-feet and may be filled 3.9 times per year. Meints Dam will be located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ and the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 04, Township 05 North, Range 03 East of the 6th P.M. in Saline County.
5. *Nebraska Revised Statutes* § 46-241(5) states in part, "The owner or possessor of a reservoir or intentional underground water storage facility does not have the right to store water in such reservoir or facility during the time that such water is required downstream in ditches for direct irrigation or for any reservoir or facility holding a senior right. Every person who owns, controls, or operates a reservoir or intentional underground water storage facility, except political subdivisions of this state, shall be required to pass ... a portion of the measured inflows to furnish water for livestock"
6. The owner or possessor of the reservoir storing water pursuant to A-19874 shall have structural controls in place or other mechanical means to immediately release a portion of the measured inflows in such amounts and at such times if so ordered by the Department.

7. A continuous recording device approved by the Department to monitor reservoir levels may be required if so ordered by the Department.
8. This appropriation is subject to the provisions of the Blue River Compact and the appropriator could be required to pass inflows if Compact flows are not being met.
9. The appropriator must comply with all relevant statutes. These relevant statutory requirements include, but are not limited to, the following:
 - A. Notify the Department of any change in ownership or address.
 - B. Receive written approval prior to taking any action that changes the storage capacity of this reservoir, plan number 21089 or the type of appropriation.
 - C. Assume liability for all damages due to leakage, overflow or structural failure of the structure.
 - D. Release a portion of the reservoir inflows for livestock where required, unless appropriator is a political subdivision.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations and any orders issued by the Director of the Department of Natural Resources may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.
