ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-19420

WATER DIVISION 1-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-19420 is held by Vaughn and Patricia Koester.
2. Appropriation A-19420 has a priority date of February 25, 2016, and authorizes the use of water for irrigation of the 121.8 acres of land described below. The water may be diverted from Loes Branch at a point of diversion located on the right bank of the stream in the NE<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub> of Section 26, Township 01 North, Range 12 East of the 6<sup>th</sup> P.M. in Pawnee County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 1.74 cfs.
